

## Appendix V: Additional Qualification Certificate programme in Managing Climate Solutions<sup>48</sup>

### I. Structure of the certificate programme

#### Art. 1 *Extent and level (Art. 4 ER BL)*

<sup>1</sup> The certificate programme extends to 24 credits, which are earned in individual courses.

<sup>2</sup> It is offered at the Master's Level and may be started only in the autumn semester.

#### Art. 2 *Courses (Art. 4 ER BL)*

<sup>1</sup> The certificate programme consists of the following courses, which are offered once a year and are as a rule taught in English:

- a) *Climate Solutions 101* (5 credits). The course has to be completed in the first semester of the chosen Master's programme.
- b) *Multidisciplinary Perspectives on Climate Solutions* (3 credits). The course has to be completed in the second semester of the chosen Master's programme.
- c) Core Electives (16 credits).

### II. Crediting and transfer of achievements

#### Art. 3 *Crediting courses and achievements (Art. 4 ER BL)*

<sup>1</sup> Students sit the examinations within the framework of the Master's Level.

<sup>2</sup> The work that has been completed is credited both towards the certificate and towards the relevant Master's programme.

<sup>3</sup> Exceptions to this are Climate Solutions 101 and Multidisciplinary Perspectives on Climate Solutions. These courses may be credited only to the certificate programme.

<sup>4</sup> The management of the relevant Master's programme respectively of Contextual Studies specify and publish the way in which credits are recorded in consultation with the Dean of Studies.

#### Art. 4 *Transfer of external achievements (Art. 4 ER BL)*

<sup>1</sup> The certificate programme must be studied at the University of St.Gallen. Credits earned in individual courses completed during an exchange semester (8 credits maximum) may be transferred towards Core Electives.

### III. Successful completion and award of the certificate

#### Art. 5 *Successful completion of the certificate programme (Art. 4 ER BL)*

<sup>1</sup> Students have successfully completed the certificate programme if

- a) the grade average of all examinations is at least 4.00; and
- b) the student has not been awarded more than 4 negative weighted credits points.

<sup>2</sup> If a student achieved a failing grade in an examination for a course, this examination may be resat once. A resit is only possible if the student has failed to complete the certificate programme successfully at the first attempt. Such students have to enrol for the course in question again. Successfully completed work of the first attempt must be taken over into the second attempt.
